TERMS AND CONDITIONS

- 1. ("DRGR") is available for use by all DRGR Members. Private group shoots may rent the Gun Range for one day at a time, with advance notice to DRGR. DRGR may rent to the general public ONLY if Members are not using the Gun Range. DRGR Memberships are available to provide preferred access, services and facility use, and other benefits. DRGR Membership is subject to the Membership Terms and Conditions stated herein. Membership will be granted, and may be revoked, at the sole discretion of DRGR.
- 2. As part of the consideration for Membership, the Member hereby agrees to remain a Member and pay the Monthly Membership Dues (if elected) for a period of not less than one (1) year from the date of this Agreement. DRGR is entitled to recover its costs, including reasonable attorneys' fees, incurred in collecting sums due to DRGR under this or any other Membership provision or otherwise.
- 3. Members may select either of the following methods of payment for their Monthly Membership dues: Automatic monthly credit payments from an

- American Express, Discover, MasterCard, VISA; or card debit from a checking account. A \$20.00 fee will be assessed for any automatic debit that is rejected for insufficient funds or any failed credit charge.
- 4. All Members, Guests, and other DRGR facility users must obey the D. Reynolds Gun Range Rules and must review, agree to the terms of, and sign the Adult Release, Assumption of Risk and Indemnity Agreement.
- 5. All Guests must be accompanied by a Member to be admitted to the firing line. Members are responsible for all actions taken by their Guests and will hold DRGR harmless for property damage, accidents and injuries to or caused by Guests.
- 6. All Members and Guests are subject to the general policies and rules of operation and administration of DRGR, all of which are intended to provide a safe, professional, friendly and family-oriented club.
- 7. Any Member or Guest of a Member may be suspended or expelled from the range and/or facility for violation of the Range Rules or for behavior deemed unsafe by DRGR personnel.
- 8. A Membership may be unilaterally terminated by DRGR if, in the sole discretion of DRGR management, the conduct of a Member or the Member's Guest presents a safety hazard to the Member or to any other user or employee of DRGR or to DRGR facilities. In the event a Membership is terminated by DRGR during the first year of Membership, the Member's Fee will be pro-rated over the first twelve (12) months of Membership and refunded for the unused months. For purposes of this paragraph, a "month" shall consist of any part of a month. For example, if a Membership is unilaterally terminated by DRGR anytime in the first month, the Member would receive a refund of 11/12 of the Fee. After 12 months of Membership, there will be no refund of any portion of the Fee. In no event will there be any refund of any Monthly Membership dues paid.
- 9. After the first year of Membership, such Membership shall be considered "abandoned" and terminated in the event of non-payment of the Monthly Membership dues for two consecutive months. There is no refund of any portion of the Monthly Membership dues paid in the event Membership is abandoned.
- 10. Any destruction of DRGR property caused by a Member or a Member's Guest, whether accidental, negligent, willful or otherwise, may result in the violator being removed from the Range and/or facility, suspended or removed from Membership if a Member, and/or criminally prosecuted. In addition, DRGR

reserves the right to assess to the Member a reasonable charge for any such damage, regardless of whether the damage is caused by the Member or the Member's Guest.

- 11. All Members must allow their photograph to be taken for DRGR records and identification.
- 12. A Standard Membership may not be transferred or sold.
- 13. All Members and Guests must present a current Membership Card in order to access the Range.



ADULT RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of being allowed to enter or use the facilities, including but not limited to the shooting ranges, (all of which are hereinafter referred to as the "Facilities") and participate in the activities of the D. REYNOLDS GUN RANGE located at 160 Precision Road, Clarksburg, WV 26301 (DRGR), I hereby agree to each of the following terms and conditions of this Agreement, and I have initialed each as having been read and understood by me.

- 1. I agree to obey and comply with the Range Rules, general policies and rules of operation and administration of DRGR. INITIALS
- 2. I am familiar with and understand the operation of each firearm (rifle, handgun, shotgun, or machine gun) which I will use at DRGR. The word "operation" includes the safe handling, loading and unloading procedures, and safety mechanisms and features of each firearm. INITIALS

I understand that DRGR highly recommends the use of newly manufactured commercial ammunition at all times on DRGR Ranges, and when live ammunition is used in the Tactical Range, I accept full and complete responsibility for the inherent risks resulting from my and anyone else's use of reloads or hand loads, including all responsibility for personal injuries to myself and anyone else. I also agree to thoroughly check to be sure I am using the correct ammunition at all times. INITIALS ______
- 4. I agree that prior to participating in or observing any shooting activities, I will inspect the Facilities, firearms and ammunition to be used and, if I believe
